## 2 Description of Service

<infinity/> is a peer-to-peer chat application that uses authenticated session establishment and end-to-end encrypted message transport. In the current implementation, users provide a shared secret that is used in key confirmation and key derivation before encrypted messaging is accepted. The Service also provides session-log export and verification features. **You acknowledge and agree that the Service is provided as a technological demonstration and for experimental and evaluation purposes only.** As such, it may contain errors, bugs, and imperfections, and its features, functionality, and availability may be incomplete or subject to significant change without notice.

## 3 User Responsibilities

You are responsible for your use of the Service and for any content you provide, including compliance with applicable laws, rules, and regulations. You are responsible for maintaining the confidentiality of any credentials used to access the Service (if applicable), and for securely managing and exchanging any shared secret used to establish authenticated encrypted sessions. You remain responsible for all activities that occur under your credentials or session context.

You acknowledge that verification results depend on correct secret handling, input data quality, and trust assumptions related to included key material.
